## 2 Prerequisites:

Exposure to Maxwell's equations and special relativity at undergraduate level will be assumed. Familiarity with the following topics will be assumed: vector calculus, complex analysis, partial differential equations.

## 3 Course description

We will begin with Maxwell's equations and the corresponding conservation laws. Green's function techniques to determine static fields (electrostatics and magnetostatics) in the presence of dielectric and permeable materials, and conductors, will be introduced.

The midterm exams will assess you on concepts covered in lectures and homework. All the midterm exams will be cumulative, but you are recommended to concentrate more on topics covered in the later part of the semester.

### Grading

The grading will be done on a scale of 0-100. This Raw Score  $x$  (out of 100) should be used to assess your knowledge in the subject. The raw score will be converted to the university scale using the following formula for Your Score  $x'$ ,

$$x' = x + ay(100 - x), \quad (1)$$

where  $0 \leq a \leq 1$  is the curve parameter chosen by the instructor and  $0 \leq y \leq 1$  is determined by your score in Extra Credit submissions (out of 1.00). For example, for  $a = 0.50$  and  $y = 0.75$ , a Raw Score of 60 will lead to Your Score of 75.
